I HEREBY EXPRESSLY ASSUME FULL RESPONSIBILITY FOR AND RISK OF LOSS OR DAMAGE TO PROPERTY OR INJURY OR DEATH TO PERSON, whether caused by the negligence of Releasees or otherwise, while I or my minor children are in, upon, or about the premises of the YMCA or using any of its facilities, services or equipment, or participating in any program or activity offered by or affiliated with the YMCA.

In the event of injury, I hereby authorize the Releasees to provide or cause to provide such medical care and treatment to myself or to any one of my minor children as may be necessary and appropriate. I understand that I am solely responsible for all costs incurred for such medical care or treatment. I further understand that if I or my minor children fail to abide by the rules and regulations of the YMCA, I or my children are subject to removal from the premises of the YMCA and/or removal from participation in YMCA programs and activities without a refund of dues, fees or other amounts paid to the YMCA.
